- 11. The sale and purchase of the Property includes the fittings, finishes and appliances as follows:-(for residential property of the Property) see the attached Schedule 2 to Condition of Sale; (for residential car parking space(s) of the Property) Nil.

#### Note on Stamp Duty 印花稅須知

On 4 November 2016, the Government announced that the Stamp Duty Ordinance would be amended to increase ad valorem stamp duty ("**AVD**") rates for residential property transactions to a flat rate of 15%. Under the Government's proposal, any instrument executed <u>on or after 5 November 2016</u> for the sale and purchase or transfer of residential property, unless specifically exempted or provided otherwise, will be subject to the proposed new AVD rate (a flat rate at 15% of the consideration or value of the residential property, whichever is the higher).
